

## Drawing Rules

**1. Eligibility:** Drawing (the “Drawing”) is open only to those who sign up in person at any of our locations and who are **of legal age** as of the date of entry. The sweepstakes is void where prohibited by law. Employees of **Hawk Inc** (the “Sponsor”) their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Drawing. The Drawing is subject to all applicable federal, state and local laws and regulations. Void where prohibited.

**2. Agreement to Rules:** By participating, you agree to be fully unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein. In addition, you agree to accept the decisions of **Hawk Inc**, as final and binding as it relates to the content. The Drawing is subject to all applicable federal, state and local laws.
